Buyer Responsibilities:

- * Have puppy examined by a licensed veterinarian within 24 hours of delivery.
- * Provide puppy with routine preventive care, such as but not limited to:
 1. Annual physical examinations by a licensed veterinarian.
 2. Follow veterinarian guidelines for vaccinations and de-worming
 3. Keep puppy off unknown surfaces until the pup is at least 16 weeks old and has all puppy shots, to prevent contracting diseases such, but not limited to Parvo and Distemper, or Show Dog Crud. We will not be responsible for puppy contracting Parvo, Distemper or Show Dog Crud or other communicable diseases once they leave our care. Protect your Puppy.
- * Puppy must be paid for by the time puppy is 7 weeks old, unless other arrangements have been made.
- * All deposits are non refundable.

Health Guarantee

* This puppy is guaranteed for 1 year against fatal and life-altering congenital defects, which adversely affects the health of the animal. This includes severe Hip Dysplasia that hampers the movement of the dog and natural gait and requires surgery to correct. Heart, Pancreas, spine and liver problems of a sever life threaten or altering nature. If the dog dies within this one year time frame the buyer will pay to have it autopsied. If the reason is congenital, or genetic, the seller will replace the puppy.

*This guarantee does not cover what in the any breed is considered normal:
 Cherry eye entropion, loose hips, skin allergies, elongated soft palate, and a stenotic snares (collapsed nostrils) red manage or Hernias of any type. * All items covered under this guarantee are by replacement only. We do not give

cash refunds.

*Seller will not be responsible for any medical expenses incurred. Buyer is aware that owning a puppy means trips to the veterinarian, and understands that he/she will be responsible for all payments.

* As of the date of delivery, the puppy has received proper vaccinations and de-worming due appropriate for its age.

* This guarantee does not include Coccidia and Kennel Cough, which can occur in puppies that are shipped and is usually caused by bacteria. Kennel Cough is self limiting like the common cold; it must run its course. Full recovery is expected and is not life threatening.

*A puppy showing any serious genetic or congenital defect will be replaced as follows. Animal must show the defect by one year of age. Seller must be notified of the problem within two business days of the licensed veterinarian determination and have two reports from two unassociated veterinarians stating the same problem and the seller will provide a replacement puppy of equivalent value.

*A returned puppy with a defect must be returned or euthanized with the prior permission of the seller, to qualify for a replacement puppy.

* No refund in part or full will be given.

*A returned puppy must be returned to the seller in good condition, other than the specified problem, at the expense of the buyer. The owner will then qualify for a replacement puppy.

Buyer is responsible for the transportation costs to and from the seller on a replacement puppy.

This guarantee applies to the original puppy only and is non-transferable to a second party.

* No replacement puppy will be given if the puppy has been bred, spayed, neutered, euthanized without permission of the seller.

* Replacement puppy will be mutually agreed upon by both parties and will be of comparable quality and value. It is understood that the replacement puppy may not be from the same parents of original puppy.

*there are certain disorders that may be caused by environmental factors. For example allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders are not covered by this guarantee.

* Any physical problem which is or could be the result of injury, over-exercise or an overweight dog is not covered by this guarantee.

* There is no guarantee or warranty that the buyer will be able to show or breed the dog, regardless of show or breeding potentials.

*Take Great care to protect your puppy from getting lost, stolen or from danger, abuse or neglect. Make sure your puppy gets enough fluids, food and rest.

If you feel your puppy is having a problem in anyway contact a vet immediately.

There is no guarantee against neglect.

*This contract supersedes any and all previous agreements.

* This contract is null and void if the terms and conditions are not fulfilled.

*Buyer agrees that he/she understands this contract fully, and that his contract is in jurisdiction of the state of Arkansas, in the county of Columbia. It is agreed that any litigation will take place in Columbia County, Arkansas.
